# freight DISCLAIMER

This applies to orders of 4' wall displays or table displays. Does not apply to mannequin and other display items which will ship with product

**Shipping:** All fixture shipments will be shipped via LTL carriers of Noelle's choice. The fixtures will be shipping from a different location than your product. If you would like the fixtures to ship at the same time as product, please provide a ship date on all orders.

**Receiving:** Since fixtures will be shipping from a different location please give a weeks time from receiving your product to contact Noelle in the case that your fixtures have not delivered. They will be shipping from different states via different modes of transportation, therefore may be delays.

**Inspecting Your Shipment:** Prior to signing and accepting any freight, please insure it has been carefully inspected for any damage. It is the consignee's responsibility to inspect their shipment for any and all damages. If the packaging shows any indication of damage or mistreatment, please open it immediately and carefully review its contents. The consignee may ask the driver to aid in the inspection of the item(s). If the item(s) have been damaged, the consignee (or the driver) must write a precise description of the damage on both the consignees copy and the freight company's copy of the delivery waybill. In the event damaged item(s) are discovered, please call Kevin @ 910-799-5603 ext. 310 immediately so that we may initiate a damage claim with the freight company. If damages are not reported and notated on the BOL, Noelle cannot honor your credit(s).

**Delivery Truck Limited Access:** All freight deliveries will arrive, in most cases, in a full size Semi truck. It is the customer's responsibility to notify Noelle at the time of placing your order, if your delivery location has limited access. In the event the delivery truck does not have access, the consignee is responsible for any additional delivery attempts and its cost(s).

**Additional Freight Charges:** Unless otherwise written on the original BOL, any and all additional charges such as; delivery appointment, lift gate service, inside delivery, change(s) of address, residential delivery, limited access, re-delivery, and storage fees will be the sole responsibility of the consignee.

**Freight Rates:** All freight rates provided by Noelle before the actual shipping of your goods are an estimate. Freight rates change daily due to zip code, weather, fuel pricing and different seasons.

**Invoicing:** There will be no customer discounts or special terms on the fixtures purchased from Noelle. All freight charges will be added to your fixture invoices. In the event that additional charges are incurred, another invoice will be created and billed to you to cover the extra charges.
